

Regina Exhibition Association Limited (REAL) Core `84 Volunteer Terms and Conditions

As accepted when you register as a volunteer:

1. The minimum age to register is 16 years of age, with some volunteer opportunities requiring a minimum age of 19 years of age.
2. Volunteers are expected to provide a minimum of 20 volunteers hours annually to be part of REAL's Core `84 volunteer team.
3. All applicants must agree to authorizing REAL to complete a basic Criminal Record Check (CRC), by completing the authorization form and presenting the appropriate identification to REAL. You will be notified when and where the forms will be accepted. If you have a CRC confirmation provided to you in the past 12 months, please upload and it will be processed. The CRC provided for Core `84 will be active for four years from the date of the letter.
4. Applicants living outside of Regina must contact the RCMP or their municipal police force to complete a Criminal Record Check. These are usually provided free of charge, when specified it is for volunteer purposes.
5. We want to make sure we are the right fit for you. Prior to acceptance a brief interview may be required.
6. General orientation and training are mandatory for all volunteers. We provide the ability to self-schedule however reserve the option to restrict the available options.
7. All volunteers are ambassadors for the organization are expected to maintain and build the good reputation and image of the Regina Exhibition Association Limited (REAL), all volunteers are expected to conduct themselves with personal integrity, ethics, honesty and diligence in the performance of their duties.
8. A uniform is required for all REAL Core `84 volunteer opportunities. The appropriate uniform will be provided to match your volunteer duties. The uniform may vary depending on the event.
9. A valid email and access to the internet is required. A primary phone number is required, a cell number is preferred.

10. At REAL, our objective is to provide a safe and healthy workplace for our employees, volunteers and contractors while delivering safe exceptional experiences for our guests. To achieve this goal, our employees and volunteers need to understand and adopt proven safety practices and work together to implement systems which eliminate or reduce hazards in our workplace.

12. You are accepting that you are volunteering at your own risk and that the Regina Exhibition Association Limited and its operating partners are not liable for any loss, injury or damages.
13. Volunteers are expected to adhere to a code of conduct as outlined in the orientation. Failure to do so may result in being deactivated from the program without notice. Should you be terminated from the program for any reason, you will be required to return accreditation immediately.
